

How to Make your Sponsor Contribution

- Contributions to approved Matching Grants and Global Grants that are sent through TRF are eligible for Paul Harris Fellow Recognition.
- To designate your gift to an approved Matching Grant or Global Grant, a grant number <u>must</u> be included. *Unidentified contributions are credited to the World Fund*.
- Contributions via check: Please make your check payable to *The Rotary Foundation*. Do not send cash.
- <u>Contributions via credit card</u>: To avoid potential decline of your credit card contribution, please advise your credit card company in advance of the contribution amount. Additionally, please only send credit card contribution information to TRF once to avoid duplicate charges.
- Contributions via wire or bank transfer: Please contact the appropriate RI office, regional office or fiscal agent listed below for wire/bank transfer information.
- <u>Currency</u>: In many cases, an RI office, regional office or fiscal agent will only accept a single currency. If this is the case, the currency is listed below. Additionally, please only send USD checks to World Headquarters, as non-USD currencies cannot be processed.
